






# How long have you worked in the planning department?





# How familiar are you with the relationship between the built environment and health?




If you are working with your local health/environmental department in planning for healthy built environments, please indicate the level of collaboration in each of the following areas.






"As part of current General Plan Update a new Health and Recreation Chapter is being written. Transportation chapter also being re-written to focus on active transportation."

"Our Board adopted Health in All Policies and have also recently approved the concept of "healthy communities" be address thought out the current General Plan Update which is in the beginning stages and expected to be adopted in early 2020 with a horizon year of 2040. We are working closely with our Public Health Department on this update."

*"We have Healthy Community policies in our General Plan with implementation measures."* 

"We have an Interdepartmental Review Team that includes all land use departments, including Environmental Health. We also have regular meetings of our Economic Development Assistance Committee (EDAC) which helps new businesses or expanding businesses with the Permit Process. This is a forum to discuss a variety of issues, including Health along with their early stages of planning their project. Lastly, we are doing a 5 year review/update to our General Plan Action items. Several of them have to do with health related issues that need to be programmed for completion in the next 5 years."





Planners do not understand health language, terms, acronyms, processes responsibility of agencies, legislative authority or mandates There is not enough time in the planning process to engage health, incorporate health into the planning and entitlement processes

Not able to engage health community in the planning process

Health/environmental department participation in planning is not mandated or authorized in code Lack of dedicated staff time and funding to participate in collaborative efforts with health

Lack of support from elected officials


Lack of support from management









### What knowledge, skills, or other support do planners and health professionals need to collaborate with health?



#### What knowledge, experience, or tools would your planning department be willing to share with others?




#### What models/approaches do you use to incorporate health and planning?





### What are the three most important areas at the local level where you see an opportunity for planners and health to collaborate to meet shared objectives?




"We have a meeting set up in March with Placer County Health to begin a dialogue."
